Policies / initiatives for 2023

Minimal conference material produced with a non-plastic recyclable badge, lanyards and foldout guide made from recycled materials that are also recyclable, and enhanced use of technology to help attendees navigate the event.

Encouraged minimal use of international speakers and any that did attend were given multiple roles. Campus, as a virtual event, is a good opportunity to bring in international speakers without the need for travel.

On-demand content library.

in person. Also, gives delegates
who did attend in person the
option to catch up on sessions
they couldn't attend.

Sustainability symposium held.

Only vegetarian food served on the final day of the event.

All social event venues within walking distance.

Encouraged delegates to bring their own water bottle to fill up from the water stations.

Section added to the Exhibitor Manual to encourage exhibitors to think about the materials on their stand including giveaways.




Venue and caterer

ACC Liverpool are 100% energy renewable certified, and send zero waste to Landfill – to read more about the venue's social impact plan please click here.


During this event, the venue caterer calculated the carbon emissions for the food served. The emissions depend on ingredients, country of origin and cultivation methods. They did this in collaboration with Klimato, their sustainability partner.

80% of food and beverage suppliers to the ACC can be found within a 30 mile radius. 60% of food and beverage suppliers are small and medium sized enterprises.



Recommendations for 2024

More comprehensive post event sustainability report to be produced post event including measuring the carbon footprint.

Track travel plans from all attendees on the registration portal as a mandatory field. This will include mode of travel and where they will travel from.

E-posters - switch off most screens outside of poster session hours. Also, review other areas of production where equipment could be switched off when not in use.

Increase the days only vegetarian food is served from one to two days.
Recommendation is for that to be
Monday and Thursday

Further sustainability sessions in the programme including in high profile plenary sessions.

Stronger messaging to exhibitors earlier on in the process to get them to think about the materials on their stands including giveaways.

BSG will provide recommendations to industry on how they can contribute to a more sustainable BSG LIVE.

Check and discuss sustainability policies with any potential venue and supplier.

Consider carbon offsetting.
